## **ORGANISATIONAL CONTEXT OF THE POSITION:**

The primary role of the Aboriginal Cultural Educator is to deliver and co-ordinate the implementation of professional and culturally responsive professional learning, education, and training.

The NSW AECG is contracted to deliver specially designed Cultural education programs that is contextualised to several government and non-government agencies, stake holders and service providers.

This role is critical to the functioning of the organisation as the position provides a very specialised program designed specifically to the needs of the organisation requesting professional learning and cultural education training and development.

The successful implementation of this program will be the ability to engage across a variety of different agencies and have a deep understanding and working knowledge of Aboriginal Peoples, Cultures, Histories and lived and shared experiences.

The Aboriginal Cultural educator will be responsible for the delivery, oversight and evaluation of the programs and meet all the reporting requirements.

The position reports directly to the President of the NSW AECG Inc.

- Experience in working across a diverse range of Aboriginal and non- Aboriginal community groups and organisations.

- Demonstrated negotiation, liaison, and interpersonal skills.
- Demonstrated and proven facilitation skills
- Ability to monitor budgets.
- Full COVID vaccinations
- NSW Driver's License and ability to travel within NSW and interstate as required
- A current NSW Working with Children Check clearance for paid employment & National Criminal History Check or willingness to obtain.

## KEY RESPONSIBILITIES/ ACCOUNTABILITIES:

- Design and deliver NSW AECG Inc. cultural education programs to the NSW Department of Education (DOE) staff.
- Design and deliver NSW AECG Inc. professional cultural education and development programs contracted to the NSW Department of Community and Justice.
- Design and deliver NSW AECG Inc. cultural education programs to government and non-government agencies, stake holders and service providers.
- Support the NSW AECG Inc. Aboriginal Language and Culture Nests.
- Provide cultural teaching, advice, and support services to DOE schools and non-government schools requiring NSW AECG guidance and input in implementing cultural education programs.
- Support the NSW AECG's Inc. cultural advocacy initiatives as required.

## FUNCTIONS:

- Provide strategic advice to the President on key issues impacting on the delivery of the Cultural education and professional development programs.
- Provide strong cultural leadership support to Local and Regional AECGs and key stakeholders.
- Provide support, supervision and direction to staff aligned on all issues and concerns regarding the delivery of cultural education programs.
- Oversee and deliver the monitoring, evaluation and reporting deadlines required of the program and position.
- Provide support to the President and to the Secretariat when requested.
